# **INSTRUCTIONS**

- i) Inquiry, if any, may be sent by Courier or Speed Post. INST will not be liable for any kind of postal delay.
- ii) The Quotation Should be addressed to the Director INST, Mohali invariably giving on the envelop Quotation for \_\_\_\_\_\_, Reference No. With date and due date with time.
- iii) The Quantity mentioned in this inquiry shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- iv) The quotation should be enclosed in a sealed envelope.
- v) Firms will quote separately for each article.
- vi) The rates offered should be FOR Mohali in case of firms situated outside Tricity and free delivery at the Institute premises in case of local firms.
- vii) GST: The Institute is not exempted from the payment of GST. The rate (i.e., percentage of taxes applicable should be clearly indicated, wherever chargeable.

# TERMS AND CONDITIONS

Important Conditions of the tender to be abide by the tenderer

- 1. **Due date**: The tender has to be submitted before the due date. The offers received after the due date and time will not be considered.
- Preparation of Bids: The offer/bid should be submitted in single bid system (i.e.) Technical bid cum financial bid. <u>The Quotations should be valid for 120 days from</u> <u>the due date.</u> The Quotations duly sealed and super scribed on the envelope with the reference No. and due date, should be addressed to "The Director, Institute of Nano Science and Technology, Habitat Centre, Sector 64, Phase –X, Mohali, 160062, Punjab" so as to reach on or before the due date.
- 3. **Delivery of the tender**: The tender shall be sent to the addressee given in para 2 (above) either by post or by courier so as to reach our office before the due date specified in our Schedule. The offer/bid can also be dropped in the tender box on or before the due date specified in the schedule. The tender box is kept in Foyer area of INST.
- 4. **Opening of the tender**: The offer/bid will be opened by a committee duly constituted for this purpose. The bidders if interested may participate on the tender opening Date and Time. The bidder should produce authorization letter from their company to participate in the tender opening. Only one representative will be allowed to participate in the tender opening.
- 5. **Acceptance/Rejection of bids:** The INST reserves the right to reject any or all offers without assigning any reason.
- 6. EMD: Tender fee/EMD is to be obtained from the bidders except those who are registered with the Central Purchase Organisation, National Small Industries Corporation (NSIC) or the concerned Ministry or Department. The details of transaction for EMD viz. Name of bidder firm, Tender Description, Transaction ID/No. of Transfer, Transaction date, Amount of Transaction, Name of Bank, Address of Bank shall be furnished by the tenderer on their letterhead separately along with their tender.

- 7. Refund of EMD: Bid securities of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. In case of successful Tenderer, it will be retained till the successful and complete installation of the equipment.
- 8. **Performance Security**: The supplier shall be required to submit the performance security in the form of irrevocable bank guarantee issued by any Indian Nationalized Bank for an amount which is equal to the 10% of Purchase value at the time of the installation of the equipment covering warranty period of the equipment and should be kept valid for a period of 60 days beyond the date of completion of warranty period.

# 9. **Reasonability of prices :**

Please quote best minimum prices applicable for a premier Research Institution. **The quoting party should give a certificate to the effect that** the quoted prices are the minimum and they have <u>not quoted</u> the same item on lesser rates than those being offered to INST to any other customer nor they will do so till the validity of offer or execution of the purchase order, whichever is later. We request you to fill the price reasonability certificate format in the enclosed file (Annexure "1")

The party must give details of identical or similar equipment, if any, supplied to any CSIR labs/DBT Institutes during last three years along with the final price paid and Performance certificate from them.

- 10. **Force Majeure:** The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
  - For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or



revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- 11. **Risk Purchase Clause**: In event of failure of supply of the item/equipment within the stipulated delivery schedule, the purchaser has all the right to purchase the item/equipment from the other source on the total risk of the supplier under risk purchase clause.

# 12. **Delivery of Goods:**

Delivery should be given at **Institute of Nano Science and Technology Lab at NPDL, Sector 81, Mohali** within a maximum of one month's time from the date of placement of purchase order.

- Delayed delivery: If the delivery is not made within the due date for any reason, INST will have the right to impose penalty @ 0.5% per week and the maximum deduction is 10% of the contract value / price.
- 14. **Prices**: The price should be quoted in net per unit (after breakup) and must include all packing and delivery charges. The offer/bid should be exclusive of taxes and duties, which will be paid by the purchaser as applicable. However the percentage of taxes & duties shall be clearly indicated.

The price should be quoted without custom duty and excise duty, since INST is exempted from payment of Excise Duty and is eligible for concessional rate of custom duty. Necessary certificate will be issued on demand. (Please refer Annexure – 2 for the price to be quoted).

16. **Resolution of Disputes**: The dispute resolution mechanism to be applied pursuant shall be as follows:

- i. In case of Dispute or difference arising between the Purchaser and the supplier relating to any matter arising out of or connected with this contract, such disputes or difference shall be settled in accordance with the Indian Arbitration & Conciliation Act, 1996, the rules there under and any statutory modifications or reenactments thereof shall apply to the arbitration proceedings. The dispute shall be referred to the Director, Institute of Nano Science and Technology (INST) Mohali and if he is unable or unwilling to act, to some other person appointed by him willing to act as such Arbitrator. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to this order.
- 17. Applicable Law: The place of jurisdiction would be Mohali (Punjab) INDIA.

# 18. Right to Use Defective Goods

If after delivery, acceptance and installation and within the guarantee and warranty period, the operation or use of the goods proves to be unsatisfactory, the Purchaser shall have the right to continue to operate or use such goods until rectifications of defects, errors or omissions by repair or by partial or complete replacement is made without interfering with the Purchaser's operation.

# 19. Installation & Demonstration

The supplier is required to do the installation and demonstration of the material within one month of the arrival of materials at the INST site of installation, otherwise the penalty clause will be the same as per the supply of materials.

20. **Warranty**: Minimum One Year Warranty shall have to be provided by the firm. The Warranty should be comprehensive on site.



## 21. Taxes and Duties

Suppliers shall be entirely responsible for all taxes, duties, license fees, octroi, road permits, etc., incurred until delivery of the contracted Goods to the Purchaser. However, GST in respect of the transaction between the Purchaser and the Supplier shall be payable extra, if so stipulated in the order.

22. **Payment**: 100% payment shall be made by the Purchaser after delivery, inspection, successful installation, commissioning and acceptance of the equipment at INST in good condition and to the entire satisfaction of the Purchaser and on production of unconditional performance bank guarantee as specified in Clause 8 of tender terms and conditions.

# 23. Drawings

- Before the goods and equipments are taken over by the Purchaser, the Supplier shall supply operational drawings. These shall be in such details as will enable the Purchaser to operate, maintain, adjust and repair all parts of the works as stated in the specifications.
- The drawings shall be in the ruling language (English) in such form and numbers as stated in the contract.
- Unless and otherwise agreed, the goods equipment shall not be considered to be completed for the purposes of taking over until such manuals and drawing have been supplied to the Purchaser.

# Experimental chamber at NPDL site

### Specifications:

- 1. PROVIDE DESIGN, fabrication and technical support for the installation of Temperature and Humidity Control chamber at the specified location at the INST sector 81 campus.
- 2. The chamber should be installed under the MS angle frame covered with cement/ asbestos sheets to prevent it from direct sunlight. Wherever required appropriate fixtures and arrangements should be provided for putting the sheet on the top of the chamber.
- 3. Chamber size 10x9 feet.
- 4. The entire internal wall panels are pre-fabricated with Galvanized Steel Frame and welded to form C-channel structural frame. PUF panel 50 mm thick for Chamber, plane powder coated (.63 mm PPGI sheets) filling with PUF which acts as a thermal barrier.
- 5. The roof of lab at 8.00 feet should be made of specialized PUF panel 50 mm thick with wall (.6 mm PCGI sheets) internal G I sheet
- 6. Double glaze glass window (5-6mm) of dimension not less than 600mm x 600mm compatible with chamber should be installed.
- 7. The panel edges should be sealed with Room Temperature Vulcanizing (RTV) Silicone to the structural frame and fasten on both sides to form an airtight sealed panel
- 8. There should be cut-outs on the walls to accommodate electrical outlets, telephone & intercom pipelines, control panels, monitoring devices and piping where ever applicable
- 9. Supply & Installation of flashing, complete with all fittings. All seams should be then carefully sealed with RTV sealant.
- 10. Corners at floor should be coved with PVC floor sheet to the wall.
- 11. The chamber should be able to maintain temperature between 23C-27C
- 12. Appropriate provision for fixing split AC should be provided.

## THE DOORS:

- 13. Supply & Installation of lab door sandwich type complete with all fittings.1000mm X 2100mm
- 14. Door should be powder-coated (for easy cleaning). The Single door should be installed completely with handle door and closer.

## THE FLOORING:

- 15. The flooring should be leveled with 1-2 inch concrete to make it even.
- 16. The floor should be covered with sheet vinyl flooring 1.5-2.0mm thick, non-skidding, abrasion resistant and chemical resistant coving up the walls.



# **ELECTRICAL CONNECTIONS:**

Supply and installation of clean room compatible lights in lab (atleast 600 to 1000 lux) atleast 2 Nos. and clean room compatible power sockets, switches approximately 4 connections of 5/15A, with 4 mm copper wiring, piping, bends, insulation etc. Installation of MCB Box outside the lab. (Main power supply till junction board near the lab is in the purview of the institute).

#### Note:

1. The panels may be required to be removed and refitted few times to accommodate the instruments without any additional cost

2. The work needs to be finished within 20 days of receiving order.
