a) Scope of Work:

For execution of the above works, total area is around 3 Acres of Institute and other labs the agency shall follow the specific requirements mentioned as under:

- 1) To execute the integrated pest control measures at INST building Mohali, INST Lab at IISER Mohali, NPDL Lab at Sector 81, Mohali including the surrounding areas within the boundary wall of INST Mohali.
- 2) Ensure that effective and economic pest control measures are implemented.
- 3) The service provider shall provide, manage and operate a comprehensive system of pest control management in accordance with the current industrial standards and the provisions of this service level specification.
- 4) To control mosquitoes (all type), agency has to fog with fogging machine (on Saturday) in entire INST Campus.
- 5) Services should be carried out every fortnight with the prior permission from the Nodal Officer designated by INST.

c) <u>Terms & Conditions:</u>

- 1) The Tenderer submitting his Tender would be deemed to have considered and accepted all the terms and conditions of Tender. No verbal or written enquiries shall be entertained in respect of acceptance or rejection of the Tender.
- 2) The Quotation Should be addressed to the Director INST, Mohali invariably giving on the envelop Quotation for ______, Reference No. With date and due date with time.
- 3) The quotation should be enclosed in a sealed envelope.



- 4) Any Tender received after the prescribed date and time in the Notice Inviting Tender will be rejected.
- 5) The incomplete tender in any respect or not complying with the terms and conditions are liable to be summarily rejected.
- 6) The successful tenderer shall have to follow all the instructions given to him/them from time to time by the competent authority or person nominated by him.
- 7) The successful tenderer and his worker shall abide by the rules and regulations of the Institute as well as directions/instructions issued by the Director of Institute or on his behalf by the authorities from time to time and violation of which may result in cancellation of the contract.
- 8) The contract period will be for a period of one year, which may be extended to further 2 years on satisfactory rendering of services.
- 9) Payment will be released within 20 days by the institute on quarterly basis after satisfactory completion of services.
- 10) The place of Pest Control Services is INST Mohali.
