Important Conditions of the tender to be abide by the tenderer

- 1. **Due date**: The tender has to be submitted before the due date. The offers received after the due date and time will not be considered.
- 2. Preparation Bids: The offer/bid should be submitted in two bid systems (i.e.) Technical bid and financial bid. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid. The Technical bid and the financial bid should be put in separate covers and sealed. Both the sealed covers should be put into a bigger cover along with letter of EMD and to be sealed. The tender number and details should be superscripted on the left side of the outer cover. The Quotations should be valid for 180 days from the date of opening of tender. #### 20. Training

The Supplier is required to train the designated Purchaser's technical and end user personnel to enable them to effectively operate the total equipment.

#### 21. Installation & Demonstration

The supplier is required to do the installation and demonstration of the equipment within one month of the arrival of materials at the INST site of installation, otherwise the penalty clause will be the same as per the supply of materials.

22. **Warranty**: Three Years Warranty shall have to be provided by the firm. The Warranty should be comprehensive on site.

#### 24. Taxes and Duties
