- 9. **Force Majeure:** The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
  - For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. - 12. **Delivery of Goods:**

Delivery should be given at **Institute of Nano Science and Technology, Habitat Centre, Sector-64, Phase 10, Mohali** within a maximum of one month's time from the date of placement of purchase order.

- 13. **Delayed delivery:** If the delivery is not made within the due date for any reason, INST will have the right to impose penalty @ 0.5% per week and the maximum deduction is 10% of the contract value / price.
- 14. **Prices**: The price should be quoted in net per unit (after breakup) and must include all packing and delivery charges. - 16. **Resolution of Disputes**: The dispute resolution mechanism to be applied pursuant shall be as follows:
  - i. In case of Dispute or difference arising between the Purchaser and the supplier relating to any matter arising out of or connected with this contract, such disputes or difference shall be settled in accordance with the Indian Arbitration & Conciliation Act, 1996, the rules there under and any statutory modifications or re-enactments thereof shall apply to the arbitration proceedings. The dispute shall be referred to the Director, Institute of Nano Science and Technology (INST) Mohali and if he is unable or unwilling to act, to some other person appointed by him willing to act as such Arbitrator. The award of the arbitrator so appointed shall be final, conclusive and binding on all parties to this order.
- 17. **Applicable Law:** The place of jurisdiction would be Mohali (Punjab) INDIA.
- 18. Right to Use Defective Goods

If after delivery, acceptance and installation and within the guarantee and warranty period, the operation or use of the goods proves to be unsatisfactory, the Purchaser shall have the right to continue to operate or use such goods until rectifications of defects, errors or omissions by repair or by partial or complete replacement is made without interfering with the Purchaser's operation.

19. **Training** 

The Supplier is required to train the designated Purchaser's technical and end user personnel to enable them to effectively operate the total equipment.

#### 20. Installation & Demonstration

The supplier is required to do the installation and demonstration of the equipment within one month of the arrival of materials at the INST site of installation, otherwise the penalty clause will be the same as per the supply of materials.

21. **Warranty**: Three Years Warranty shall have to be provided by the firm. The Warranty should be comprehensive on site.

Note: <u>If the OEM warranty is for 12 Months</u>, additional extended warranty of two years should be quoted separately with or without price.

22. **AMC**: Annual Maintenance Contract (AMC)/Comprehensive Maintenance Contract (CMC) up to next five years after warranty period is over should be quoted separately.

#### 23. Taxes and Duties

Suppliers shall be entirely responsible for all taxes, duties, license fees, octroi, road permits, etc., incurred until delivery of the contracted Goods to the Purchaser.
